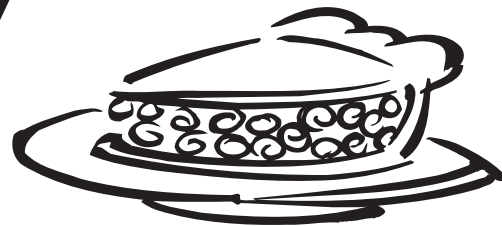


## Signal Mountain Road Race

**DATE and TIME:** Saturday, October 23, 2004, 8:00 a.m.

**STARTS and FINISHES:** Signal Mountain Middle School

Directions: Take Route 27 to the Signal Mountain Exit. Follow Signal Mountain Road (Route 127N) up the mountain, several miles past the traffic light. Turn right onto Ault Road just after Shoal Lane and just before the grocery store.

**COURSE DESCRIPTION:** A beautiful, rolling course with two significant hills. Beautiful views over East Brow Road.

**REGISTRATION FEES:** Registration may be made by pre-registering or sign-up the morning of the race from 6:45 a.m. – 7:30 a.m. Registration fee is \$10.00.

**NEW THIS YEAR:** This year there will be a prediction race. Prize money (\$50, 30, 20) for the top three runners that come closest to predicting their finish times. (note: no watches allowed during race.) A split time will be given at the one mile mark. Your prediction must be clearly marked on your race application in the space provided. In order for to qualify for the prize money, finishing time must be less than 70 minutes.

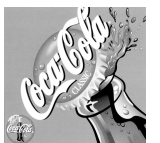
